

They do not consider payment of tax as part of management of their businesses. This is making a lot of them to pay huge sums of money as penalty, when the arm of the law catch up with them.

A correct attitude towards payment of tax would make you to save on tax through help from contemporaries and consultants.



Secret 2: Know and Understand the Tax System

here is a saying that "what you don't know may kill you".

Knowledge is power. That is why the taxman will tell you 'ignorance is no excuse'.

Some forms of business entities require that the business pay taxes on the money it earns throughout the year AND that the business owner pay taxes on the income he or she receives.

This results in a double taxation scheme that costs the business twice. Most types of business entities, however, do not have to pay double taxes, and any tax owed is paid by the owner who receives the income.

This is beneficial because it keeps money in the company and the business owner pays no more tax than would have been paid originally.

When structuring your business then, make sure you choose a form of business that will avoid double taxation and help you meet your tax saving goals.



Secret 4: Know the Type of Tax You Are Liable To And The Tax Authority

Dayment of Tax is part and parcel of managing a business. But in Nigeria, many SME businessmen do not always see it that way.

Some business owner-managers do not know the type of business taxes that they supposed to pay, when and how to pay it.

Some do not even bother to consult with a Tax consultant.

Knowing the type of business taxes you are liable to pay, when and how to pay it will eliminate payment of penalty and interest on your tax liability.

As a fall out from this, most owner-managers do not know that not all their expenses are allowable for tax purposes, exemptions.




Secret 5: Maintain Proper Book and Records of Accounts

ven though you may use a casual approach to recordkeeping for your personal taxes, you can't do this for business. "The tax law specifically requires certain records in order to take deductions," Weltman says. "Without these records, legitimate expenditures may not be deductible."

Here's what you need to comply with tax rules:

- A system to track your income and expenses. This is easily done with computer-based recordkeeping solutions that enable you to handle this matter yourself.
- Procedures to collect and store required receipts and other proof of expenditures. Set up file systems to categorize your receipts (e.g., carrelated expenses, meals and entertainment costs, and capital expenditures)



Secret 6: Organizing and Classifying Your Expenses

he tax laws does not permit all types of expenses, the thinking of most businessmen is that they can incur any type of expenses.

This is not so, the tax laws has certain category of expenses that are allowable, while the rest that are not allowable are called disallowable expenses.

And these disallowable expenses are added back to profit or loss of the company to arrive at assessable profit.

It is advisable for any business to try as much as possible to organize and classify its expenses according to the provisions of the law.



Secret 7: Proper Documentation and Filing of Tax Returns


ou can drastically reduce your business taxes by ensuring that your business transactions are properly documented through the use of good source documents like invoice, payment vouchers, petty cash vouchers, goods received notes, receipts, etc.

All these will be useful to defend your business in case of any issue with the tax authority.

Closely related to this, is maintenance of good tax records. Ensuring that all correspondence, returns (VAT, Withholding Tax, etc), tax clearance certificate and others are filed in a safe place.

Then, make sure, all returns are filed as at when due. This is because lateness in filing returns increases tax liabilities through penalty.

In most cases the penalty can be mind boggling.



Secret 8: Use Expert Tax Planning

his is an advanced way of reducing your tax liability. This can only be done with your tax consultant.

It involves meeting certain conditions like:

- a.) A good business and accounting system with proper records and necessary controls.
- b.) A good budgetary systems.

The above are necessary because tax planning involves taking advantage of the provisions of the tax law as it affects your sector, industry and business so that you can pay a small amount of tax in compliance with the law.

The payment of low tax can be done if we engage in expert tax planning. Yet, in many cases, especially those which involve business taxes, expert tax planning is a must.
